## Brain-Stem Death & the Halachic Organ Donor Society

To the Editor:

Dr. Leon Zacharowitz (Brain Death is Not the Final Word, Op-Ed 11/17/06) is correct in noting that Jewish sages are divided about whether or not brain-stem death is halachic death. That is why the Halachic

Organ Donor (HOD) Society (www.hods.org) offers a unique organ donor card that allows people to express their desire to donate organs at the moment of brain-stem death (the ruling of the Chief Rabbinate of Israel) or, alternatively, for those who choose to donate organs after cessation of heartbeat.

Although the HOD Society has 147 rabbis who carry its organ donor card, the HOD Society is mainly an educational organization and does not decide, nor issue, psak halacha. As such, there is no need to restrict board membership to Rabbis.

The purpose of our two-day seminar at the Albert Einstein Medical School was to have rabbis and physicians learn about brain-stem death from both a medical and Halachic perspective. Physicians are not always familiar with Jewish law, and Rabbinic sages are not always familiar with medicine. In this respect, the seminar was extremely successful in sharing information between these two communities. The seminar lectures are available in both audio and video format www.hods.org.
